



## Competitive Trail Challenge Recognition Procedure #:

**Purpose:** This procedure provides guidance for National Walking Horse Association (NWA) to recognize competitive trail challenges.

**Scope:** This procedure applies to any NWA personnel who wish to recognize or organize an ACTHA affiliated (or other organizations) Competitive Trail Challenge.

CTCs do not have to be specifically oriented toward gaited horses but must not exclude them from fair competition.

### Responsibilities:

<b>TITLE</b>	<b>Description</b>
Directors	Directors assure that the rules for CTC are in place and meet the needs and desires of the membership.
Director of Operations	Provides a venue for formal recognition. Provides forms, maintains and files copies. Assures that information is provided on web site and in NWA News.
Trail Committee	Solicits CTC hosts. Provides information to NWA membership. Promotes Competitive Trail Challenge opportunities.

**Procedure:**

NWHA strives to improve the opportunities of gaited horse owners to compete in venues that emphasize safety and the humane treatment of horses.

To this end, NWHA will solicit hosts to provide ACTHA Competitive Trail Challenges (and other organizations). NWHA will recognize these CTCs and promote them through whatever venues are available to it.

**To recognize a CTC, complete the following:**

- The CTC organizer will complete a “CTC recognition” form (Appendix A). Submit the form to the corporate office either electronically or on paper along with the current fees noted on the application.
- The Director of Operations or her/his designee will affirm that the form is received.
- The Director of Operations or her/his designee will add the CTC date, time, and location to the NWHA Calendar, so that it will appear both on the web site and in the NWHA News (if time permits).
- If the CTC organizer wishes, they may write a short course description to be posted on the web site along with the date and time.
