

## NWHA Versatility Judges Clinic Registration Form

A Versatility Judging Clinic will be held at the Middle Tennessee State University Horse Science Complex, in Murfreesboro, Tennessee on November 5, 2009. The National Walking Horse Association will provide the Versatility Clinic to all NWHA Licensed Judges.

**WHO:** The National Walking Horse Association is extending the Judging Program to educate all current judges in the versatility divisions.

**WHAT:** This NWHA Judges Versatility Clinic will be offered to current licensed NWHA Judges to continue their education in the divisions of Trail Western Riding, Reining, Hunter Hack, Working Hunters, Trail Obstacle, Dressage, Barrel Racing, Pole Bending, Obstacle Driving, Equitation and Showmanship Divisions

**WHEN:** Thursday, November 5<sup>th</sup> from 8:00 AM to approximately 5:00 PM

**WHERE:** MTSU, Horse Science Complex, Murfreesboro, TN

**WHY:** The purpose is to continue the educational training of judging the versatility of the Tennessee Walking Horse and to promote educated qualified judges for the increasing growth of the versatility divisions. Attendance at this clinic fulfills the requirement of attendance for NWHA Judges to attend a judges clinic every two years. Judges will be given the opportunity to earn their versatility license at the conclusion of the clinic by passing the versatility test. Versatility test questions are based on all aspects of versatility judging and are not limited to only the areas covered in this clinic.

**COST:** Thanks to the generosity of Duke, Rhonda and Allison Thorson, there will be no cost to NWHA judges. However, judges are responsible for their transportation and hotel expenses. Renewal of judges' licenses can take place at this clinic for the standard fee of \$100.00.

\*The Annual Judges Clinic covering both rail and versatility classes will be held in February.
