Shoes will be removed at the discretion of show management and/or officials for inspection and weighing.

As per NWHA rules – “No shoe can be made from any material heavier than conventional steel.”

If a horse is found to be non-compliant with these NWHA rules all awards/monies, points and show fees for that exhibitor and horse shall be forfeited.
